**Race Rules and Requirements:**

**Race Director has the authority to enforce all rules and disqualifications.**

1. Early sign ups at Islander Lodge from 7-9 pm Fri Jan 20. **PLEASE SIGN UP EARLY IF YOU PLAN TO RACE SO THE RACES ARE NOT DELAYED AND YOU SAVE \$20.00.**
2. Late sign ups at the Islander from 8 –9 am Sat. Jan 21, 2011- \$20.00 RACER FEE ENFORCED.
3. Mandatory attendance at drivers meeting at 10:45 am, Jan 21, 2011 at the Islander Starting Line.
4. Race will start at 11 am sharp.
5. Pro Open, Semi-Pro, Vets and Women will race approximately 150 miles. Course runs from the Islander Lodge to Skwentna and back.
6. Juniors race approximately 82 miles. Course runs from the Islander to Luce's and back.
7. There is a \$70 Gas Charge for Pro, Semi Pro, Vets, and Women and a \$30 Gas Charge for Juniors.
8. Racers must follow marked course only. All racers must stay within 50' of marked trail with no exceptions.
9. Mandatory 5lb fire extinguisher in your pit.
10. Machine equipment required: All machines must be registered with the State of Alaska DM V. Snow flaps must be secured. Headlights, if glass must be taped, if acrylic taping not needed. Brake light must be taped. Headlight must be fully functional as well as brake light. Tether switch required on all sleds. Race numbers must be displayed on windshield 6" minimum or on both sides of cowling 6" minimum in contrasting colors. All gas cans must be USCC approved.
11. Driver equipment required: Drivers number must be displayed on back of garment a minimum of 8" or by wearing a numbered bib. All drivers must wear 2005 to current Snell Approved Helmet. AMMC recommends that the helmet be 75% orange in color

but is not mandatory. It is recommended that racers wear full coverage helmet. Juniors must wear full coverage helmet, no exceptions. Goggles, TekVest, shin guards and good winter boots are required. AMMC/WRL membership is mandatory.

12. Finish time deadline is 4:00 PM, Jan 21, 2011.
13. **Course/Checkpoints** – Mile 10 Four Corners, Luce's, and Skewtna.
14. ATT-Alascom Motorola 2 way radios will be used on course. We will have communication the full length of course will all officials.
15. Course will be marked Jan 15. We will leave Big Lake at 10:00 am from the Islander Lodge to mark the course. All persons interested in helping please meet there on the 15<sup>th</sup>.
16. Cancellation date Thurs the 20th, 2011 at 6:00 p.m. Check website/facebook or your email for info.

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering of any such restricted areas, and will continuously thereafter inspect the restricted areas, which he/she enters, and he/she further agrees and warrants that, if at any time he/she is in or about restricted areas, and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and if necessary will leave the restricted areas and/or refuse to participate further in the event(s).

2. Hereby releases, waives, discharges, and covenants not to sue AMMC/WRL, or the promoters, participants, racing associations sanctioning organizations or any subdivision thereof, track operators, track owners, officials, advertisers, owners and lessees premises used to conduct the event(s), premises and event inspectors, surveyors, underwriters, consultants and other who give recommendations, directions or instructions or engage in risk evaluation or loss control activities regarding the premises or event(s) and each of them their directors, officers, agents, and employees, all for the purposes herein referred to as "Releasees" from all liability to the undersigned his legal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore or account of injury to the person or property or resulting in death of the undersigned arising out of or related to the event(s), whether caused by any partial or sole negligence of the Releasees or otherwise.

3. Hereby agrees to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to the event(s) whether caused by any partial or sole negligence of the Releasees or otherwise.

4. Hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the event(s) whether caused by the partial or sole negligence of Releasees or otherwise.

5. Hereby acknowledges that the activities of the event(s) are very dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned, also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees.

6. Hereby agrees that this Release and Waiver of Liability assumption of Risk and Indemnity agreement extends to all acts of partial or sole negligence by the Releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by the laws of the State in which the Event(s) is/are conducted and that if any portion thereof is held invalid it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Hereby agrees that photographs, video productions and telecasts may be made of the undersigned either alone or together with others, during the race event or at such times or places as AMMC/WRL shall designate. The undersigned agrees that all rights in such photographs, video productions and telecasts including, but not limited to, rights of sale, reproduction, use and distribution, shall belong to AMMC/WRL and/or an AMMC/WRL affiliate its successors or assigns, which may make whatever use of such photographs, video productions and telecasts as it or they may desire. The undersigned hereby grant to AMMC/WRL and/or an AMMC/WRL affiliate, its successors and assignees the non-exclusive right to use the undersigned's name or likeness for any and all commercial benefit and purpose, without limitation, in perpetuity, through the universe, in all media whether known or unknown.
